If you have concerns

Safeguarding is everyone's responsibility. If you are worried about something, it's really important that you say something about it.

If you have concerns about the immediate safety of someone, please contact the police right away.

Dos and Donts

Creating a positive environment depends on people treating each other respectfully and with encouragement. Modelling good behaviour is something we should all do, thinking carefully about the consequences of our words and actions.

You should never:

- Allow concerns to go unreported
- Engage in behaviour that is in any way abusive, harmful, negligent or exploitive
- Use any type of physical punishment
- Act in any way which may be perceived as threatening, intrusive, intimidating, patronising, bullying or belittling
- Use inappropriate language, including sarcastic remarks, insensitive, derogatory or sexually suggestive comments
- Engage in any sexual activity, promote or encourage sexual activity, expose Children and/or Adults at Risk to any form of sexual content / image / activity
- Subject anyone to any form of treatment that is harmful, abusive, humiliating or degrading

If you are a coach, official or administrator, you should never:

- Put yourself in a position where you are alone with a child or an adult at risk, including transporting a child or an adult at risk or in a home
- Directly contact a child or an adult at risk via any electronic or written means
- Follow children or adults at risk from your personal social media accounts, engage with any of their posts or post about them on your accounts
- Place yourself in a changing room unless accompanied by another registered adult who has a valid DBS certificate on file

Safeguarding requirements

We do have certain requirements that vary according to roles within the club, especially for individuals who are part of teams with players under 18. If you have any questions about whether you are currently compliant or you need help meeting requirements, please contact the Club Welfare Officer.
